BUT THEN AGAIN, THAT IS A RARITY. THIS INFORMAL ENFORCEMENT IS GENERATED FROM THE EXPECTATIONS OF FELLOW RIDERS AND THE OF COMMON COURTESY THAT **FNVIR ONMENT** FUNCTIONS IN THE UNDERGROUND.


